

# HOLY SEE and VATICAN CITY STATE PASSPORTS

General information (*security features may be found in the official folder*)

The Holy See and Vatican City State are both subjects of international law – identified by the same ICAO code: VAT – presided over by the Pope, through:

- The Secretariat of State, which is competent for diplomatic relations between the Holy See and the international community;
- The Governorate of Vatican City State, which supervises the territory of Vatican City according to the sovereign wishes of the Pope.

Each entity issues its own passports.

The Holy See has two kinds of electronic passports: *diplomatic* and *service*, as well as the *temporary service* passport, which is not electronic.

The Vatican City State has an electronic *ordinary* passport.

All four Vatican passports can be optically read and are ICAO DOC 9303 compliant.

Nationality – Vatican or other

Renewal – possible (handwritten): *if renewed*, the passport is to be considered as an emergency travel document

Issuing – centralized, Secretariat of State of the Holy See (Vatican City)

Issuing Authority signature – for internal use only. A) and B) on biodata page. C) on page 5

e-pass – C) = S.A.C. (*Supplemental Access Control*)

Issuing Authority signature – for internal use only. A) and B) on biodata page. C) on page 5

Validity – 2013 – 2025: 2 years (max); **starting 18 DEC 2025: 1 year (max)**

Nationality – not Vatican

Renewal – possible (handwritten): if renewed, the passport is to be considered as an emergency travel document

Issuing – centralized, Secretariat of State of the Holy See (Vatican City)

Issuing Authority signature –for internal use only, on biodata page.

Biometric – MRTD, photo ICAO 9303 compliant

Issuing – centralized, Governorate of Vatican City State

Issuing Authority signature – no Authority signature.
